Dear C-3/R-3 Sanitation Customer:

Beginning Saturday May 12<sup>th</sup>, the Town of Surfside Beach will begin its 2018 summer rollout service for all properties within the C-3/R-3 zoning districts. Summer rollout service will continue until Saturday September 8th. Summer collection will be three (3) times per week: Monday, Thursday, and Saturday with rollout service for each cart.

All sanitation customers within the C-3/R-3 zoning districts will be billed the Summer Sanitation rate beginning in June. Summer rollout charges will total **\$76.25 per month/per cart** broken down as follows: \$18.75 x 3 time per week service = \$56.25; plus \$20 summer roll-out service charge. Charges will be billed to your GSW&SA account for June, July, August, & September. We strongly encourage use of free recycling carts provided as overflow trash results in extra carts/fees.

**EXEMPTIONS ALLOWED FOR:** Permanent residents (owners of residential property only), non-rentals, long-term lease (those who rent for 30 consecutive days or longer to the same tenant), and annual leases. **You must respond to this notice to receive an exemption.** Exemptions will not be granted over the phone. This signed form along with required documentation must be returned by mail, email, fax or in person to Pubic Works or Town Hall. Exemptions will not be granted for properties providing short-term rentals which are required to have a Town business license. To be granted an exemption, check the appropriate box below, sign and return the form **with required paperwork.**

**2018 – 2019 WINTER SANITATION ROLL OUT – OPT OUT FORM**  
**R3 Residents Only**

**Winter rates** shall be a price of **thirty dollars and seventy-five cents (\$30.75) per month/per cart**, broken down at eighteen dollars and seventy-five cents (\$18.75) plus a twelve dollars (\$12.00) winter roll out curb service fee from Saturday, September 8<sup>th</sup>, 2018 until the first Saturday in May, 2019. Charges will be billed to your GSW&SA account October through May.

Town Ordinance Sec 7-12 b (2) states: **Winter roll out** curb service of twelve dollars (\$12.00) per month shall be optional for the total R-3 district and shall be **mandatory for the total C-3 district**. Persons or properties who want to opt out of the winter roll out curb service in the R-3 district shall notify the Town of Surfside Beach Public Works Department. This notification shall be made each and every year that a person or property want to opt out of the winter roll out curb service to the Surfside Beach Public Works Department. Failure to notify the Surfside Beach Public Works Department shall result in that person or property in the R-3 district being charged a winter roll out service of twelve dollars (\$12.00) per month.

**Be advised** – Persons or properties who opt out of winter roll out curb service are responsible for placing moby cart(s) curbside for service on the scheduled collection day. Sanitation crews **WILL NOT** roll out cart for service.

---

Town Ordinance Sec 7-12 b (2) further states: If a cart for a person or property that has opted out of the winter roll out services is rolled out to the street and the person or property fails to remove the cart from the street, or if waste or garbage becomes a health or safety hazard, the Surfside Beach Public Works Department can reinstate the winter roll out service fee of twelve dollars (\$12.00) without notifying the person or property who chose to opt out.
