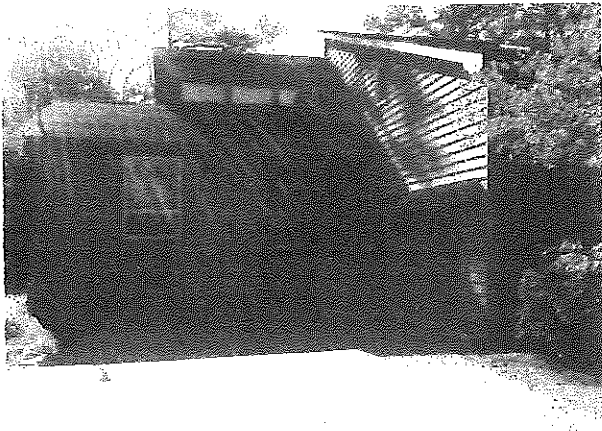

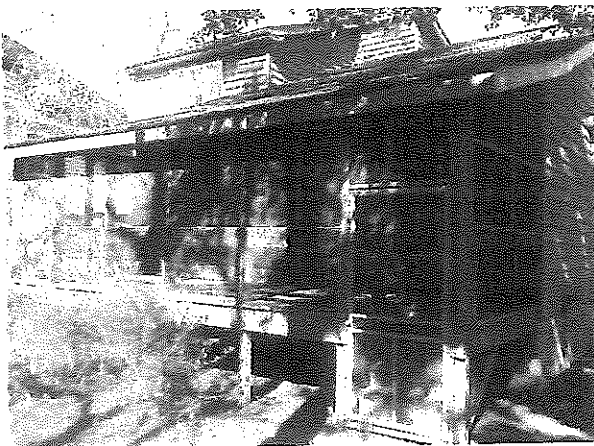

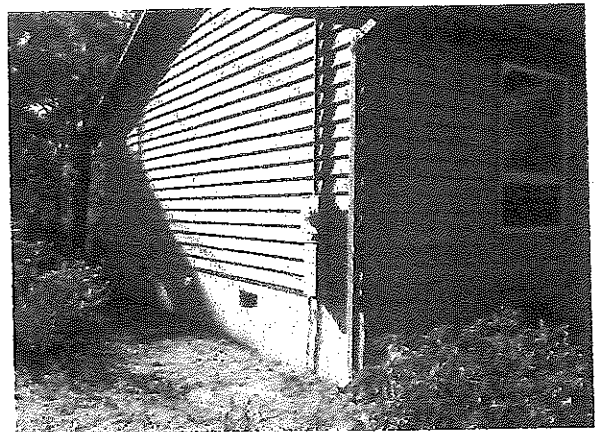
FRONT VIEW
