We have had a busy year with many new and exciting things going on for our beautiful town.

On April 8th we had our Town Municipal Election which resulted in a run-off held April 22nd. We had a great turnout and a lot of dedicated residents who volunteered to help out at the polls. We thank each volunteer for their assistance in both of the elections. The Election re-

Business, citizens and local government need one another, but we do not always appreciate one another. When that is true, there is often a lack of communication. This information will help you understand when business licenses and permits are required and when you may need more information before proceeding. You can also visit the Planning, Building & Zoning page on our website: www.surfsidebeach.org. Please contact us with any questions, we look forward to speaking with you!

Q: When is a business license required?

A: Any type of business that is opening or offering services within the town limits is required to have a business license issued by Surfside Beach. For license rates and requirements, please contact the Finance Department

at 843-913-6342. Contractors must also possess valid state of SC licenses for their trade.

Q: Under what circumstances is a building permit needed?

A: Before you can construct a new building, add on to an existing building, demolish, alter, make other than ordinary minor repairs or perform electrical, plumbing, heating or air conditioning work you will need to obtain a permit. Always check before proceeding with any construction or repair activity.

Q: Do I need to be concerned with flood plain management and high wind building requirements?

A: Yes, whether you build or alter, FEMA flood plain regulations and hurricane/wind construction requirements will have an impact on your construction. Obtaining and maintaining certain types of insurance is dependant on meeting these requirements. The town does have flood hazard areas and is in the National Flood Insurance Program.

Q: Do all new structures and additions to existing ones require storm-water runoff control measures?

A: Yes, all new commercial construction and additions, as well as residential construction in the R-1 (if you exceed 40% impervious coverage), R-2 and R-3 zoning districts, will require storm-water runoff control measures.

Q: Who handles water and sewer service within the town limits?

A: Water and sewer services are provided by Grand Strand Water and Sewer Authority. For water and sewer information call 843-443-8200 or 443-8202.

Q: Does Surfside Beach have restrictions for zoning with regard to parking, land use, setbacks, etc.?

A: Yes, make sure the type of business or type of structure you want to build is permitted in the area of town where you want to place it. Businesses or residences in different Zoning

Districts are subject to different yard setbacks, parking requirements, density limits, height restrictions, landscaping and sign requirements.

Q: Do storage buildings, swimming pools, fences, etc. require permits and inspections?

A: No, all types of accessory uses are regulated by setbacks, location and size requirements. Permits and inspections are required for certain accessory uses and you should always check with the building department before proceeding.

Q: Are signs, outdoor displays and banners regulated by the town?

A: Yes, our sign ordinance regulates the type, size, number, height & location of all types of signs. Permit is required for permanent or temporary signs. The display of certain types of merchandise outside of any building is prohibited except with a permit for limited special events. Special permits are required for these and other types of

conditional uses.

Q: Is landscaping required for all buildings and do I need a permit to cut down trees?

A: Yes, our tree protection ordinance requires that an inspection be done and a permit be obtained before cutting down a tree. Call 843-913-6341 to arrange for an inspection of any trees. In addition, minimum areas of landscaping are required around all businesses and residences.

Q: Can I keep old vehicles or “junk” in my yard?

A: In residentially zoned districts, storage of “junk” or unlicensed vehicles, in plain sight, and dereliction of property are prohibited. Commercial vehicles larger than a standard van are also prohibited from overnight parking.

Q: Can I construct or develop property on the beachfront?

A: Our Shore Protection Ordinance protects the beachfront sand dunes and limits development activity seaward of a shore protec-

tion line along the oceanfront. Permits are required for any development, construction or disturbing activities in this area.

Q: Are there public street right of ways in place?

A: Yes, encroachment of landscape shrubbery, fences or other hard structures into public easements is prohibited.

Q: Where can I obtain information on waste management and recycling?

A: For information on containerization, collection schedules, yard debris, old appliances & demolition debris, call the Sanitation Department at 843-913-6360.

The Building and Zoning Department is always available to assist Residents and Contractors. Call or visit our offices with any questions. Contractor permits are issued from 8:00 AM to 1:00 PM. Our Code of Ordinances is available online at: www.surfsidebeach.org.

Business License Renewals and Requirements

Under the Town of Surfside Beach Code of Ordinances every person engaged or intending to engage in any activity with the object of gain, benefit or advantage is required to pay an annual license fee and obtain a business license. According to the Ordinance any business or individual furnishing short or long-

term rental space for a fee is considered a business and is therefore, required to obtain a license based upon the gross receipts from such rental.

A separate license is required for each location. License period runs from June 1st through May 31st.

Renewals were mailed mid April and required payment to be made on or before June 1, 2008.

Congratulations to Sharon Leahey, who was recently awarded the accreditation in business licensing (ABL).

The requirement included completing a 3 year training program and passing the ABL exam.

pany, Cooper Sand and Gravel, will move next to Floral Lake to continue dredging while concurrently excavating Magnolia Lake, which has become too shallow to dredge. Meanwhile the Storm Water Committee is evaluating the excavation of Myrtle Lake as an add-on to the contract. All the money and effort the Town is expending on this project will have a very positive effect on the quality of our storm water. The proactive thinking of our Town Council and Storm Water Committee members on this issue is to be applauded.

This fall most of the remaining beach crossovers will be completed. The town is looking for groups or individuals to volunteer to take care of a crossover. Your name or group name would be identified at the crossover. The town would supply all needed materials, including plants. It would be a rewarding project for the right people.

Although the town is only 4 months into this year's budget, we are currently working on next year's. To that end I am putting to-

gether for presentation a base budget which looks at the needs and necessary enhancements rather than just adding the inflation rate to the current one.

The Council has earmarked \$150,000 for beautification projects in town. The new budget also includes increased provisions for the maintenance of our beach.

In April, the Town Council selected Mr. Ty Taylor as the new Director of Public Works. Mr. Taylor was formerly a Superintendent of Public Works for the Town of Ayden in North Carolina. In his former position, Mr. Taylor was in charge of the town streets, sanitation, mosquito control, cemeteries, storm-water, right of ways and paving and cutting contracts. He has been in construction since the age of 15 and holds a certified license in pesticide application. We welcome Mr. Taylor who is proving to be a great addition to the town staff.

Another addition to our staff is Valerie Riley who joined us on March 4. She serves our Town Court as Deputy Clerk of Court/

Ministerial Recorder. Valerie Wentz, our Associate Judge and Clerk of Court, is especially delighted to have Ms. Riley working with her as she brings many years of valuable experience from both the Municipal and Magistrate Courts with her.

We also extend congratulations to Mike Lewis for his newly attained Adjunct Instructor status from the SC Fire Academy. Firefighter's who have been granted this status are able to give instruction in fire departments throughout our region.

On a personal note, I have heard from a few of the Surfside residents that they feel the Administrator should live in town. I am a private individual but for the record, I do live in town. I have resided on Lake View Drive for some time now.

Public Works: Recycling Update

The new MRF (Material Recycling Facility) is now fully operational. Director Ty Taylor and Executive Assistant Joan Saleem attended the Grand Opening ceremonies and were treated to a tour of the new facility on April 29. This new state of the art recycling center is very impressive. Crews have delivered over 2100 of the new blue recycle carts throughout town. We have seen an increase in our recycling collection to more than double the amount collected in the

blue bags. On the average we were collecting about 25.5 tons of recycling materials per month. In April of this year we collected 31.48 tons, compared to 24.41 tons in April 2007. In May of this year we collected 38.26 tons of recyclable materials compared to 28.70 tons in May of 2007. All of this results in not only reduced tipping fees for us at the landfill but more importantly less tonnage that goes into the landfill as well as more materials available for recycling.

Summer Sanitation

Our summer sanitation collections begin at 6 a.m. Please make certain that your moby and/or recycle carts are curbside by 6:00 a.m. on your scheduled day of collection. The three times a week collection continues until Sunday, September 7.

There will be trash collection on Monday, September 1.

Public Works: Streets and Drainage

50/50 Program: During the fall and winter months crews completed thirty-two 50/50 projects throughout town. The program has been suspended during the summer months but will resume in the fall. Applications are still being accepted and will be considered based on the date received when the project resumes. Applications are available at Town Hall or at Public Works.

Beach: Crews rake the beach and pick up trash three days each week. Swashes are cleaned out as needed to ensure proper

water flow. Several repairs have been made to beach accesses and will continue as time allows. Trashcans on the beach are being serviced five days a week including Saturdays and Sundays.

Lakes: Cooper Sand & Gravel continues dredging Cherry Lake. They are on schedule and will move to Floral Lake next. Environmental Testing Services is testing and monitoring the lakes so that we can document the water quality before, during, and after dredging. Estate Management continues to treat the

other lakes every other week.

14th Avenue South Underground Utilities: Project is underway. Bids are going out for an electrician.

Landscape/Maintenance: Crews have been busy mowing, weeding, and cleaning town properties and parking areas. Flowers have been planted along several of the islands. Ditch cleaning and maintenance is ongoing. Town signs and street signs have been repainted or will be replaced.

Surfside Bans Biker Vendors for Two Years

Temporary motorcycle event vendors are now banned for two years from Surfside Beach during May's annual biker rallies, after Town Council on Tuesday approved a moratorium.

The action comes on the heels of Myrtle Beach's aggressive campaign to end the rallies that attract thousands of motorcycle enthusiasts to the area each year.

The ban in Surfside Beach is intended to protect residents from the traffic congestion and noise pollution that plague the area each May as thousands of motorcyclists travel to the Grand Strand, Mayor K. Allen Deaton said.

"We're overwhelmed during the biker weeks. What happens is the gridlock on [U.S. 17 S. business] and Ocean Boulevard creates a problem for people trying to leave their neighborhoods. Our tourism area is only about three blocks wide. When [bikers] venture out of that three-block area, they are basically in our neighborhoods. Noise is the major problem," Deaton said.

As a result of the moratorium, the town will lose

about \$4,500 in vendor permit fees. Deaton said the town spends more money on overtime and public safety than it brings in from the permits. The town issued eight vendor permits, five tent permits and 12 banner permits last year, Town Clerk Sharon Pinnell said.

Deaton recognizes the number of permits issued is not large, but said it will help to relieve some of the congestion off of its major tourists roads.

"Our attitude is not to eliminate the Harley-Davidson rally. It's to control it," he said.

Surfside Beach and Myrtle Beach are both part of the Coastal Alliance and agreed during a recent meeting that the bike rallies were a problem.

Surfside Beach decided to move forward on its own, but the city of Myrtle Beach plans to ask Horry County and North Myrtle Beach to join in and take action to restrict vendor activity during the rallies, said City Manager Tom Leath.

A meeting of the Grand Strand Coastal Alliance for all governments affected by the bike rallies is tentatively

scheduled for August to create a plan, Leath said.

"I think the city will be pleased that the Town of Surfside Beach has taken this action," Leath said. Taking away licenses "itself will not curtail all activities, but it's a step in the right direction."

Despite protests from some businesses that the rallies provide an economic boon to the area, Myrtle Beach passed a 3-mill property tax increase on June 17 to dedicate to an anti-bike rally campaign.

The city's council members have also passed first reading to change the city's OZ-50 zoning so vending permits cannot be issued in May. OZ-50 covers the Myrtle Beach Convention Center and Broadway at the Beach, two spots that in years past have drawn motorcycle-related vending, Leath said.

The city started its efforts in response to residents' complaints about increased crime and traffic congestion. The city spends an extra \$300,000 or so each year on the bike rallies, between additional law enforcement, overtime, trash clean-up and other services, city spokesman Mark Kruea said.

Town Votes to Buy Pier in Surfside

Town officials have decided to buy the Surfside Beach pier from Scalise Development for \$2.5 million.

Town Council approved a resolution Tuesday to reallocate \$900,000 in accommodations tax dollars from beach renourishment funds to be used for the pier purchase. The town used federal money to pay for beach renourishment, leaving ac-

commodations tax money available to go toward buying the pier, Mayor K. Allen Deaton said.

The remaining \$1.6 million for the pier is expected to come from enterprise funds, which includes money the town collects through parking meters and leases on property it holds, Deaton said.

The deal to buy the pier was made several weeks ago and

will not be finalized until the end of September. Tuesday's actions approved the funding mechanism for the pier purchase.

"The pier is a landmark in Surfside Beach. I think the residents are really excited about this," said Councilman Bob Childs.

Surfside Pier was originally built in 1953. It has been rebuilt at least three times.

Dial 911 for all emergency, fire, rescue, or police calls!



Evacuation, Pet Care, Disaster Kits, Insurance Policy Review are among the many points of concern when considering preparing for hurricanes and other emergency events.

Hurricane Season began June 1st and will continue through November 30th. Be prepared and evacuate when asked to do so.



If you are requested to evacuate, you should do so as quickly as possible. When winds reach 40 mph emergency vehicle dispatch will be selectively restricted to serious emergencies and at 60 mph sustained winds, emergency vehicles will be removed from the roads. This means that if a member of your household becomes ill or injured, or if you need other assistance, emergency personnel will NOT be able to reach you.

Hurricane Preparedness Tips from Our Fire Chief

Before a Hurricane

- Gather disaster supplies and create a basic supplies kit, which you can use at home or take, if you evacuate. Include ...
 - “2008 South Carolina Hurricane Guide”
 - Non-perishable food (including canned goods)
 - Drinking water (two quarts per person per day)
 - Flashlights, extra batteries, and bulbs
 - Battery-powered AM/FM or hand crank radio and NOAA weather radio with extra batteries
 - First-aid kit and manual
 - Non-electric can opener
 - Essential medicines, including prescriptions
 - Sturdy shoes
 - Baby supplies (including baby food and diapers)
 - Games and books
 - Fire extinguisher
 - Important documents (insurance policies, family records, photo identification, important telephone numbers, tax records, bank information)
 - Toiletries and other personal hygiene items
 - Cash and credit cards
 - Road maps
 - Jumper cables
 - Tire repair kit
- If you live in a vulnerable area be prepared.
 - Plan an evacuation route and learn the locations of official shelters
 - Be prepared to drive at least 20 to 50 miles to locate a safe place.
 - Make arrangements for pets. (Pets are not allowed in most official shelters.)
 - Fuel up family vehicles and service them.
 - Bring inside or otherwise secure all outdoor items.
 - Turn off gas, electricity, and water.
 - Stay tuned to your local television and radio stations for emergency information.

During a Hurricane

- Stay tuned to your local television and radio stations for emergency information.
- Stay inside a well-constructed building away from windows and doors, even if they are covered. Go to an interior first-floor room, basement, closet, or under the stairs.
- Be alert. Tornadoes are often spawned during hurricanes.
- If the “eye” of the storm passes over your area, be aware that severe conditions will return with winds from the other direction in a very short time.

After a Hurricane

- Wait until an area is declared safe before entering. Roads may be closed for your protection. Do not drive in flooded areas.
- Check gas, water, electrical lines and appliances for damage.
- Avoid using candles and other open flames indoors. Use a flashlight to inspect damage.
- Report life-threatening emergencies only.
