**WHEREAS**, the Town of Surfside Beach Town Council in chambers duly assembled in a regularly scheduled meeting held on the 24<sup>th</sup> day of November 2015; and

**WHEREAS**, Ralph Magliette was instrumental and proactive in the creation of the *ad hoc* Senior Citizens Advisory Committee through his advocacy through Councilmembers for the creation of the Senior Citizen Advisory Committee; and

**WHEREAS**, Ralph Magliette was involved with charities and the Senior Citizens Center in providing great help to the Seniors of the Town of Surfside Beach; and

**WHEREAS**, Ralph Magliette was instrumental in setting up many senior programs with the Surfside Beach Library, areas churches in Surfside Beach, and creation of the first ever Senior Citizens Fair, creation of the senior survey, creation of the neighbor to neighbor program, creation of the senior citizens activity program, creation of the senior citizens fire safety program, creation of the senior citizens Community Policing program, creation of the senior citizen program for theft deterrent, creation of the Senior Citizens program for CPR and other life-saving classes with the fire department, creation of the senior calendar, and funding for the senior citizens exercise stations at the passive park; and

**WHEREAS**, the Town of Surfside Beach has lost a champion for senior citizens with the passing of Town Councilmember Ralph Magliette; and

**WHEREAS**, the naming of the *ad hoc* committee for Ralph Magliette violates no written policy of this town.
