To Create SURFSIDE BEACH BUSINESS COMMITTEE

WHEREAS, the Town of Surfside Beach Town Council in chambers duly assembled in a regularly scheduled meeting held on the 24th day of July 2012; and

WHEREAS, successful businesses are essential to the long term health of the Town of Surfside Beach and Town Council desires to improve communication and implement necessary regulations consistent with the business community's interests, and also cultivate a business friendly environment to help new and existing businesses succeed and prosper within the Town of Surfside Beach.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Surfside Beach Town Council does hereby establish the *ad hoc* Surfside Beach Business committee for the purposes herein stated, and that appointments shall be made by Town Council and the committee shall operate pursuant to Town Code with a goal of developing and recommending to Town Council strategies and policies to be implemented that will promote a successful business community within the Town of Surfside Beach; and

BE IT FURTHER RESOLVED, that this committee shall review applicable ordinances, and make appropriate recommendations to Town Council; this committee shall continue to promote the Family Beach atmosphere for town businesses, promote improvement and overall appearance of town businesses; and

BE IT FURTHER RESOLVED, that said committee shall consist of seven (7) members comprised of a majority of current or former resident business owners and a minority of non-resident business owners, who shall be in good standing with all town ordinances representing retail, service, hospitality, and/or trades; and one non-voting councilmember whom shall serve in an advisory capacity.
