WHEREAS, the Town Council of the Town of Surfside Beach held a General Municipal Election Runoff on Tuesday, April 19, 2016 for the purpose of electing three councilmembers, each of whom shall serve a four-year term beginning May 10, 2016 and ending May 12, 2020; and
